4.3 <u>Wounded Warriors Canada</u>

Mr. Phillip Ralph, National Director of Wounded Warriors Canada gave a presentation to the Board highlighting the programs available.

Ralph, a retired military officer and chaplain, currently serves as a pastor in Ajax.

He said that while the government assisted returning veterans with their physical needs, mental health services were lacking years ago. Through partnerships with police, fire and EMS, programs have been made available to those in need in various fields.

The colour of the uniform doesn't matter when it comes to those suffering from post-traumatic stress disorder. "It does the same thing to the individual," he said. "Trauma is trauma."

Some of the programs available include Trauma Resiliency Program for individuals and couples program (COPE), Animal Assisted Programs such as Therapy Dogs and Equine Therapy, and Resiliency Training and Respite Care-operational stress programs. He urges different branches of emergency services to continue their respective PTSD programs as well and not to stop doing what you're doing, WWC is an added layer of support.

Support for couples is important, since those with healthy relationships often fare better in their work and other aspects of their lives.

With efforts to minimize overhead and other costs, Wounded Warriors is able to put about 80 per cent of expenditures towards programming. Approximately 2,000 veterans, first responders and their families are supported each year.

Programs take place in regional hubs, which improves the efficiency of delivery, we like to take the programs to the people.

The Mayor asked about the funding of the programs, Mr. Ralph gave an example a funding of a course such as COPE would be \$50,000.00, which includes full travel costs, housing and meals. The Mayor further suggested an objective to reach out to the Chiefs of London and Windsor and the OPP to collaborate a regional model. It is a great opportunity to form a regional model that does not stop at our borders.

Chatham-Kent police Chief Gary Conn recommended to the board that CKPS enter into a partnership with the organization, along with fire, EMS and military in the area. The COPE, Trauma Resiliency and the Before Operational Stress Program (BOSS) would be beneficial for CKPS. The MOU- will provide programs and proactively working with our members and general/mental health
