4.3 Operational Support Branch Annual Report

The Chief turned the presentation and Report to the Branch Commander Inspector Trevor Crane for the 2018 Annual Report.

The Operational Support Branch oversees a number of specialty units within our department, such as Major Crime Investigators, as well as members from the Investigative Support and Intelligence Sections. There is 28 sworn and civilian staff that make up the Investigative Branch. All members have specialized training in their respective fields and provide direct support to the Community Patrol Officers. I will call upon the subject matter experts to give you an over-view of 2018.

The following officers gave a brief overview and statistical information on the various units in the Operation Support Branch:

-In the absence of Detective Sergeant Keith Myers Sergeant Steve Kloostra-Immediate Supervisor will present the report on the Major Crimes Unit and Investigative Support Unit.

-Sergeant Kloostra gave a summary of the departments he is directly responsible for: the Internet Child Exploration Unit (ICE), Digital Forensics Unit (DFU), Forensic Identification Unit (IDENT), Child Abuse Investigation Team, Crime Stoppers Officer, Analytical Unit and Sex Offenders Registry.

-Constable Rich Kwon who is a Certified ICE Investigator presented the section on Internet Child Exploitation Unit and Sex Offender Registry.

-Tony Fasullo Digital Forensics Unit (DFU), works closely with ICE Unit on various types of crimes -Detective Constable John Hicks presented the section on Child Abuse Investigation Team Unit

-Constable Steve Hubley presented the section on Forensic Identification Unit (IDENT) and the Unit has three licenses to a web-based system for identification through a provincial data base with the RCMP.

-Constable Dave Bakker presented the report pertaining to Crime Stoppers

-Sergeant Terry Marchand presented the report on Intelligence/Drugs/Streets Crime Unit

-Staff Sergeant Michael Domony presented the portion on Professional Standards and Public Complaints and Internal Affairs, Commendation and Recognition and Recruits, Lifelong learning-Educational Reimbursement Programs, Risk Management and Use of Force.
