## 5. Reports from Deputy Chief:

# 5.1 <u>Chatham-Kent Police – Multi Facility Security Enhancements</u>

Acting Deputy Chief-Kirk Earley presented the report on Chatham-Kent Police – Multi Facility Security Enhancements.

Deputy Chief Earley highlighted the importance of updating the current security system at Police Headquarters and in the outlaying substations. An internal review identified the need to enhance the current security system. Phase 1 (1st Quarter of 2020) is Security Cameras at a total cost of \$50,710.40 and Phase 2 (3rd Quarter of 2020) is a Door Access/Card reader Security System at a total cost of \$88,448.25

The enhancement will address the physical aspect of safety and security as well as the technological security measures set forth by external partners. It is our responsibility to ensure the security measures in all stations meet the National Police Network Connection Authorization Change Request (NCACR) and the Criminal Intelligence Service Canada Regulations (CISC). Presently the Avigilon camera/security system at Headquarters is of a high standard and quality and served the police service very well. However, the enhancements to the system has greatly advanced over the years and as such, we should harness these advancements to augment our ability to maintain the safety and security of our employees and our property.

## 5.2 Police Check Adjustment 2020

Acting Deputy Chief-Kirk Earley presented the report on Police Clearance Check Adjustment 2020. In September 2013, the Board approved the implementation of the online police clearance check system including a nominal increase in the fees that citizens were charged. The fee increase was to help offset costs associated with offering a more convenient online system for citizens to submit their check

requests. The Vendor charges CKPS \$9.95 for every online check completed. The CKPS chose to absorb the per check fee within that fee increase.

To help offset the annual rate of inflation increases as well as the increased labour burden costs incurred since 2013, the recommendation is to increase the police clearance check fee for employment related checks only from \$35.00 to \$40.00 effective January 2020. There would be a zero increase for volunteer or student fees. The fee increase would be \$5 per check keeping the CKPS fee close to the provincial average of \$40.00.

There has not been an increase since 2013.
