#### 4.2 Crime Severity Index Report 2019

The Chief presented the Crime Severity Index Report 2019 released by Statistics Canada on October 29, 2020. The Crime Severity Index (CSI) is a measure of police-reported crime that reflects the relative seriousness of individual offences and tracks change in crime severity. It compliments two other measures of crime: the police-reported Crime Rate which measures the volume of crime, and victimization survey data, which measures Canadian experiences of Crime.

The Chief highlighted various sections of the report and the Severity Index Numbers for Crime, Non-violent Crime and Violent Crime.

The CSI rose nearly four per cent nationally in 2019 to 79.45, but Chatham-Kent saw its CSI drop to 69.6 last year from 75.60 in 2018.

This puts Chatham-Kent nearly 10 points below the national average and well below the municipality's own five-year CSI average of just over 76.

Chatham-Kent ranked 25<sup>th</sup> overall to non-violent crimes and 45<sup>th</sup> in 2019 placing us near the bottom in respect to violent crimes out of 50 police services.

Councillor Crew commented on the report and thanked the department for the hard work. The Chair commented on the progress made on the non-violent crime status, it has been a level of concentration by the force over the last few years and it is nice to see a positive result.

#### 4.3 Chief's Commendation

The Chief deferred to the report to Deputy Chief Earley to present the commendation.

The Deputy Chief presented the facts surrounding a Police Assist Call CK20046331 on Tuesday September 8, 2020, officers were summoned to the Third Street Bridge in regard to a suicidal female. The Officers located the Female party with a rope ties around her neck and the other end ties to the bridge and she was standing on the bridge, ready to jump. Constable Jeremy Weedon and Sergeant John Deforest engaged in conversation as Constable Kieran Crosby, Gary Oriet and Staff Sergeant Greg Cranston stood by. As the officers continued to speak to her, without warning the individual let go and jumped. Officers Weedon, Crosby and Cranston managed to grab a hold of her and pull her back to safety. She was apprehended under the Mental Health Act and taken to the hospital for treatment. Constable Paul Hendrie assisted by liaising with the family and searched her room. He located a suicide note on her IPad along with razor blades hidden in her room, which she had injured herself earlier, if not the fast thinking and action of these officers, no doubt she would have carried out her threat to kill herself and have further means to re-injure herself immediately upon getting home.

For your actions, you are being recognized by way of a Chief's Commendation for your excellent team work, collaboration, communication skills and judgement.

## 5.1 <u>2021 Fleet Acquisition-Front Line General Patrol Vehicle Replacements</u>

Deputy Chief Kirk Earley presented the 2021 Fleet Acquisition-Front Line General Patrol Vehicle Replacement Report.

The Police Service is in the process of replacing 7 front line cruisers due to high mileage or the repairs begin to become excessive for those fleet units.

Each vehicle is replacing a similar class vehicle as per our fleet budget and will be supplied by Fiat Chrysler Automobiles (FCA)

The replacement vehicles will be a 7 -2021 Dodge Chargers (\$33,421.00 Tender Price per vehicle x 7 =\$233,947 plus Vehicle Equipment (radio, roof light, protective cages, push bumpers) \$10,593 per vehicle x 7 = \$74,151.00) **Total Purchase Price \$308,098.00** 

The vehicles will be purchased through the Provincial Co-Operative Group (PCPG), which offers discounted pricing for policing agencies across the province, using the existing budget allocated for the purchases.
