Overview:

Arry was born in Slovenia May 11th 2012; he was imported by Metro Detroit Schutzhund Club and sold to Chatham-Kent Police in April of 2013.

In 2013, Arry and Constable Bertok attended Windsor Police Service for the Basic Canine Handlers course, certifying and graduating in August of 2013 as a Dual Purpose Police Canine. Since then, the Canine Unit has been tasked in dealing with issues relating to tracking for missing or wanted persons, open searches, building searches, searches for property or evidence, apprehension of armed or fleeing suspects, high-risk arrests and vehicle stops, searching for firearms, narcotics, ammunition, and community relation events to name but a few.

Since becoming operational, Arry and Constable Bertok have provided front line and canine patrols regularly augmenting our front line shifts. They have been utilized in a 24/7 on-call basis, and deployed on a number of drug related search warrants, having been successful at detecting drugs and stolen property within our community.

During their tenure, they attended approximately 700 canine related calls, effecting 75 canine arrests, while detecting and recovering four firearms. During warrants, vehicle searches and open searches Arry detected on an estimated \$128,015 of illegal drugs, and recovered approximately \$11,635 worth of stolen property, which was returned to their rightful owners.

Arry and Constable Bertok remained beyond proficient and maintained an "Above Standard" during their training. This is in addition to mandatory yearly certifications through the Windsor Police Service Canine Unit. Further training included participating in certifications provided by the United States Police Canine Association, Region 19.

Notable Highlights:

- August 7-9, 2015: Attended USPCA Region 19 PD1 certification. Awarded: 1st place Criminal Apprehension, 1st place Searching, 1st place Obedience, 1st place overall PD1 dog, Top Rookie dog and Top Apprehension Dog Boris Award.
- May 1-4, 2016: USPCA PD2 Certification- Narcotics Detection and Tracking U of M, Ann Arbor, MI 1st place Narcotics team, 5th place Tracking.
- May 21-24, 2017: USPCA PD2 Certification Narcotics Detection & Tracking Port Huron, MI.1st place tracking.
- Sept 10-13, 2017: USPCA PD1 Certification Sterling Heights, Michigan 1st Place Searching, 1st Place Agility, 3rd Place overall PD1 canine.
- October 20, 2018: USPCA PD1 Certification Washtenaw County, MI First Place overall in Regional Match 1st Searching, 1st Obedience, Agility, 1st Apprehension, 1st overall PD1 dog, Borris Award-Top Apprehension dog.

This Board report provides an overview of the exceptional last seven years of work and service completed by Constable Bertok and his partner Arry. They have both clearly taken great pride in serving our community and the Chatham-Kent Police Service.

As a result of their exemplary years of service and sacrifice, the Chief has recommended that both Constable Bertok and his partner K-9 Officer Arry receive this CITATION from the Police Services Board.



Dear Sirs/Mesdames:

On June 25, 2019, the Hon. Pablo Rodriguez, PC, MP, then-Minister of Canadian Heritage and Multiculturalism, announced that the Government of Canada would adopt the International Holocaust Remembrance Alliance's (IHRA) definition of anti-Semitism as part of *Building a Foundation for Change: Canada's Anti-Racism Strategy 2019–2022.*

The IHRA's definition, explained further at its website <u>https://www.cija.ca/ihra/</u>, is as follows:

"Antisemitism is a certain perception of Jews, which may be expressed as hatred toward Jews. Rhetorical and physical manifestations of antisemitism are directed toward Jewish or non-Jewish individuals and/or their property, toward Jewish community institutions and religious facilities."

Accordingly, at its meeting of October 29, 2020, the Halton Police Board adopted the following resolution:

THAT the International Holocaust Remembrance Alliance (IHRA) definition of antisemitism as adopted by the Parliament of Canada be endorsed by the Halton Police Board, and;

THAT the Board Chair write a letter to the Councils of the Regional Municipality of Halton, the City of Burlington, the Town of Halton Hills, the Town of Milton, the

Town of Oakville and all Police Boards in Canada encouraging them to endorse the IHRA definition.

I invite you to consider adopting a similar resolution at your respective Councils and Boards in order to demonstrate support for Canada's Jewish Community.
