Elevations


It is recommended that Grade 7b Level 1 ECO, Dominick North, be elevated to Grade 7b Level 2 effective January 24, 2021.

Overview


In 2017 the Chatham-Kent Police Service incorporated policy and procedures surrounding the Collection of Identifying Information in Certain Circumstances (CIICC) as per Regulation 58/16 of the Police Services Act.

As part of this regulation the Chief of Police shall provide the Police Services Board an annual report. The annual report shall include statistical data related to the collection of identifying information. Below is the data related to the collection of identifying information for the Chatham-Kent Police Service since 2017.

Throughout 2020, officers with the Chatham-Kent Police Service did not interact with members of our community that would have initiated CIICC documentation. In medium to smaller communities such as Chatham-Kent, the general public would come to expect that their police service is well aware of the criminal sub-culture. As such, members of the CKPS during 2020 conducted 1,595 person stops with known individuals. At no time during these interactions did officers gather new identifying information from the individual. These interactions are created to track the day to day activities of our officers, it also allows the service to pro-actively engage members of our community. Typically these interactions could be related to; community engagement, criminal investigation, traffic enforcement, intelligence lead policing, proactive policing, or simply observations.

In July of 2020, Cst. Corey Aitken learned of a possible illegal marihuana grow located on Maynard Line in the Municipality of Chatham-Kent. Cst. Aitken took the information received and began to gather tombstone data and further intelligence on the property and suspected illegal marihuana within said property. Once Cst. Aitken formed grounds to believe that an illegal grow operation was at the target location, he enlisted the assistance of the Chatham-Kent Police Service Intelligence Unit.

A judicial authorization was applied for and obtained to search the premises. Officers located and seized over 7 million dollars in illegal marihuana. The investigation continues to this date to identify the suspect(s) involved.

Cst. Aitken is a dedicated young officer, who showed great, initiative, tenacity and a keen criminal mind while gathering and investigating this incident.


